The said re-employment is subject to the following terms and conditions.

- i. The re-employment will be made for a period of one year or till the vacancy is filled up on regular basis, whichever is earlier.
- ii. The re-employment may be terminated by Works Department at any time for dissatisfactory performance, on notice of one month. In case of any misconduct including misappropriation, negligence in duty or causing loss to the Govt., the services may be terminated without any prior notice.
- iii. Besides the action under condition (ii) above, the re-employed Officer will also liable to proceeded against under the provision of the Odisha Pension Rule for any act of misconduct during the course of discharging duties under re-employment.
- iv. General Instructions of Govt. regarding terms and conditions for re-employment of Officers as issued from time to time will be applicable and binding on the Officers.
- v. In case he desires to resign from the engagement, he may do so by giving a notice of one month in writing to the Commr.-cum-Secretary to Govt., Works Department, under intimation to the Controlling Officer. After expiry of the notice period, the Officer may be relieved after handing over the full charges of the records and cash/Bank Accounts to the Relieving Officer as decided by Works Department on the Controlling Officer.
- vi. The re-employed Officer will be subject to and will abide by the Conduct Rules applicable to the Govt. Servants.
- vii. These terms and conditions are subject to Codal Provisions/ Memorandums/ Resolutions issued by Finance Department from time to time.
- viii. The re-employed Officers are entrusted with the powers and responsibilities as indicated at para 2.2.62, 2.2.64, 2.2.65 and 2.2.66 of OPWD Code Vol-I.
- ix. During the period of contract, the appointee may be accommodated with Govt. Quarters, subject to availability, provided he will pay normal rent as applicable to Govt. Servants availing the Govt. accommodation.
- x. The pay of the re-employed Officer will be fixed in consultation with Finance Department.
