No. OE-I-MISC-0003-2020 / 2119 /W, The following retired Civil Engineers are hereby re-engaged as OSD on Contractual Basis, for a period of One Year from the date of their joining as such. They are requested to join in this Department immediately.

2. Sri Damodar Sahoo, Retd. Superintending Engineer, Works Cadre

The re- engagement of the above officers are subject to following terms & conditions

- I. The re-engagement will be made for a period of One Year.
- II. The re-engagement may be terminated by Works Department at any time for dissatisfactory performance, on notice of one month. In case of any misconduct including misappropriation, negligence in duty or causing loss to the Govt., the service may be terminated without any prior notice.
- III. Besides the action under condition (ii) above, the re-engaged Officer will also be liable to proceeded against under the provision of the Odisha Pension Rule for any act of misconduct during the course of discharging duties under re-engagement.
- IV. General instructions of Govt. regarding terms & conditions for re-engagement of Officers as issued from time to time will be applicable and biding on Officers.
- V. In case he desires to resign from the engagement, he may do so by giving a notice of one month in writing to the Commissioner-cum-Secretary to Govt., Works Department, under intimation to the Controlling Officer. After expiry of the notice period, the Officer may be relieve after handling over the full charges of the records and cash/Bank Accounts to the Relieving officer as decided by Works Department or the Controlling Officer.
- VI. The re-engaged Officer will be subject to and will abide by the Conduct Rules applicable to the Govt. Servants.
- VII. These terms & conditions are subject to Codal Provisions/ Memorandums/ Resolutions issued by G.A & P.G. Deptt. / Finance Department / Works Department from time to time.
- VIII. Further any addition in terms and conditions will be intimated.
