- 5. If he fails to submit his written statement of defence within the stipulated period of 30 days from the date of receipt of this memorandum, it will be presumed that he has no explanation to offer and action will be taken, as deemed proper, ex parte.
- 6. The receipt of the Memorandum should be acknowledged by him.
