Sub:- Amendment to codal & contractual provision.

After careful consideration Government have been pleased to make following amendments to codal & contractual provisions.

1. Amendment to Para-6.3.15-OPWD Code, Volume-I.

The following financial power shall be substituted in place of the existing power under Para-6.3.15. of OPWD Code, Volume-I.

Competent Authority	Tender Finalisation Power
a) Administrative Department	Above Rs.10.00 crore (Where there is a post of E.I.C.) Above Rs.7.00 crore (Where there is no post of E.I.C.)
b) E.I.C.	Above Rs.7.00 crore and up to Rs.10.00 crore
c) Chief Engineer	Above Rs.4.00 crore and up to Rs.7.00 crore
d) Superintending Engineer	Above Rs.1.00 crore and up to Rs.4.00 crore
e) Executive Engineer	Up to Rs.1.00 crore

A public works officer may accept a tender for work up to the amount to which he is authorised to accord technical sanction to estimate provided that any provision in the tender does not infringe any standard rule or order of a higher authority and that no provision involves an uncertain or indefinite liabilities or any condition of an unusual character (see also Paragraph-3.5.4.).

Notes(I)-

The Departments / Wings where there is post of Engineer-in-Chief, tenders for works above Rs.10.00 crores should be referred to the Administrative Department who will refer it to a Committee consisting of Secretary of the Administrative Deptt, Secretary of the Finance Department, Secy. of the Law Deptt. and Chief Engineer concerned. The Financial Adviser or Assistant Financial Adviser of the Department will act as member Secretary of the Committee. Secretary of the Finance Deptt. and Secretary of Law Deptt. may send their representative not below the rank of Deputy Secy. of the respective Departments, if they so desire. In case, the members of

the Committee come to a unanimous decision, such recommendation of the Committee should be communicated to the Chief Engineer after obtaining orders of the Govt. in Administrative Department. In case the members express divergent views on any point, final decision in the Administrative Deptt. be taken after obtaining orders of Government.

Note-(II)- The Departments/wings where there is no Engineer-in-Chief, tenders for works above Rs.7.00 crores should be referred to the Administrative Deptt. for finalization of tender as per procedure mentioned in Note-I.

Note-(III)- Finalisation of tender for the works above Rs.4.00 crores and up to Rs.7.00 crores will be done at the level of Chief Engineer through a Tender Committee constituted with concerned Chief Engineer as Chairman. Superintending Engineer of the same office & Superintending Engineer of concerned Circle as members and Financial Adviser/AFA/Accounts Officer of the same office as Member Secretary. Similarly, finalization of tender for the works above Rs.7.00 crores and upto Rs.10.00 crores will be done at the level of Engineer-in-Chief through a Tender Committee constituted with Engineer-in-Chief as Chairman, concerned Chief Engineer as member and Financial Adviser/AFA/Accounts Officer of the same office as Member Secretary. In case of divergent views of Tender Committee, final decision will be taken by next higher Authority. For this purpose Engineer-in-Chief will be treated as next higher Authority of Chief Engineer, where, there is no post of E.I.C., the matter will be referred to the Administrative Department.

Provisions made in existing Note-IV to Note-VII of this para remains unaltered.
